Please read carefully the following provisions and disclaimer which will allow us to care for your pet.**

- 1) Owner understands that there are inherent risk of illness or injury when dealing with animals and humans in a group situation. Such risks include, but are not limited to: problems associated with rough play such as bite wounds, sore muscles and tendons, and scratches. Owner understands and agrees that under no circumstances shall Karen's Animal House, Inc. be responsible for illness or injury to pets participating in Day Care, and that in such an event, the provisions of Section 6 shall not apply.
- 2) Day Care is available for dogs do not have temperament or social issues. If your dog exhibits aggression, shyness, or other dangerous behavior with people or dogs, it will be removed from the Day Care room. You will be called and notified of such behavior. Karen's Animal House, Inc. will not tolerate any dangerous behavior from the dogs in Day Care.
- 3) Day Care is for animals which have been neutered or spayed. Young puppies which have not been altered will be accepted in Day Care until such a time that hormonal problems begin to occur.
- 4) Day Care is for healthy animals which do not have any of the following medical conditions: diabetes, seizures, heart murmurs or any other medical condition which will be aggravated by rough play or excitement. Karen's Animal House, Inc. assumes no responsibility for any aggravation of an unknown medical condition while engaging with other dogs in Day Care.
- 5) Owner understands that all health and behavior problems with their pets have been disclosed to the best of the Owners knowledge.
- 6) The employees of Karen's Animal House, Inc. will take all precautions to ensure your pet(s) against any injury, escape or death while in Day Care. Karen's Animal House, Inc. will not be held responsible for any injuries which may occur, provided that standard care and precautions have been followed as determined at the sole discretion of Karen's Animal House, Inc.. It is expressly agreed by Owner and Karen's Animal House, Inc. that liability shall not exceed the lessor of the current chattel value of a pet of the same species or the sum of \$200.00 per animal. In no event shall Karen's Animal House, Inc., it owner or agents be liable for illness that may arise during Owners pet(s) while in Day Care at Karen's Animal House, Inc.
- 7) Owner understands that the Owner is solely responsible for any harm caused by Owners pet(s) while in Day Care at Karen's Animal House, Inc.
- 8) This contract contains the entire agreement between the parties. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives and assigns of Owner and Karen's Animal House, Inc..

I have read, understand and agree to all provisions of this agreement. I fully intend to pick up my pet(s) by 6:00 pm on the day I left it for Day Care. If my circumstances change, I will notify Karen's Animal House, Inc. of said changes and assume full responsibility for any other additional charges incurred.
